Hello EOC Tech Fall 2021 Adult Student:

You may be eligible to receive an American Rescue Plan (ARP) HEERF 3 Student Grant, which was approved by Congress and the U.S. Department of Education. The following are the eligibility requirements at EOC Tech:

- · Have financial need due to the COVID-19 pandemic;
- Be enrolled as an adult student in a full-time career major as of September 3, 2021; and
- Return the application form to Student Services at EOC Tech no later than Friday, September 24, 2021

The application forms are available in Student Services. Please turn in your completed form to Student Services **no later than Friday, September 24, 2021**. If you are out due to COVID-19, please contact Ms. Prior and other arrangements will be made. If we do not receive a completed application form from you by the deadline date, we will assume that you do not want the student grant and the funds will be allocated to other adult students who meet the criteria listed above.

You will receive another email when your student grant check is ready to be picked up. The estimated disbursement date will be mid-October. You will sign for and pick up your check from Mrs. Hodge in the Bursar's Office across from Student Services. Once you have picked up your check, please cash it or deposit it as soon as possible, i.e. do not hold onto the check.

There are four categories that will be used to determine how much each student will be awarded; they are determined by your enrollment status and your 21-22 FAFSA. The categories are:

- Full-time/Pell-eligible
- Half-time/Pell-eligible
- Full-time/Not Pell-eligible
- Half-time/Not Pell-eligible
